Images will be exhibited at the Spring Fair, April 15th–18th, at the Western Washington Fairgrounds in Puyallup.

WHO CAN ENTER: Amateur photographers who derive less than 50% of their income from photos. See Age Groups

ENTRY LIMIT: You may enter as many photos as you wish.

CATEGORY: Open to any subject, this is a family Fair, inappropriate subject matter will be disqualified.

ENTRY FEE: Adults \$7.00 per photo Youth \$3.00 per photo. Make checks payable to Tacoma Photographic Society.

REQUIREMENTS: Images may be film or digital but must originate in a camera. Minimum print size 8" X 10", Maximum entry size (including matt) 16" X 20". Entries may or may not be in a matt. Entries **MUST** be mounted on a stiff backing (matt board, cardboard etc.) in order to stand on the display rack. **NO FRAMES.** Entries **MUST** have a title and the maker's name, age group, address, and phone number on the back, in the upper left corner. No name or title may appear on the front. Images entered in prior Spring Fair Competitions are not eligible.
